

## IMPORTANT FACTS

### *WHAT ARE THE 2009 MANDATORY REGULATIONS?*

In 2009, The Pt Board of California (PTBC) enacted regulations that require all California licensed Physical Therapists to obtain 30 contact hours of continuing education during the two year renewal period. Course work must be related to the practice of Physical Therapy. However, the PTBC has also included mandatory course work that must be done within each 2 year period.

### *WHAT IS THE MANDATORY COURSEWORK?*

The PTBC has concluded that 2 hours of coursework covering California Physical Therapy laws, regulations, and ethics must be done within the two year renewal period.

### *WHERE CAN I TAKE THESE COURSE?*

Not all courses may qualify. Courses must be from an approved provider and course content must meet the PTBC's requirements for laws and ethics. NIRE is an approved CEU provider and all courses meet the PTBC's content requirements.

### *WHERE CAN I ORDER THE MANDATORY COURSEWORK?*

NIRE has created a convenient home study course that can be downloaded in an electronic format (PDF) or a CD can be mailed.
